### Cease Fire Tip Leads Deputies to Guns and Drugs Arrest

The Leon County Sheriff's Office, working in conjunction with Big Bend Crime Stoppers, received a tip through its Cease Fire initiative. The tip led deputies to 24-year-old Devin Bragg who was living in the 1800 block of Robinson Road. Bragg had an active warrant for Carrying Concealed Firearm out of Wakulla County. The tip alleged Bragg was in possession of a firearm while dealing in illegal narcotics.

Deputies with LCSO's Special Projects Investigations Detection Enforcement Response (S.P.I.D.E.R.) were able to determine that Bragg was inside the residence last night and made contact with him there.

Inside the residence, deputies also located four firearms (A handgun, two shotguns, and a rifle), 73.8 grams of Xanax pills, 11.5 grams of Oxycodone pills, 98.8 grams of "Shrooms" (Psilocybin "Mushrooms"), 8.3 grams of MDMA, 5.9 grams of cocaine, 7.7 grams of methamphetamine, 215.8 grams of cannabis, 23 vials of THC, 12 packages of "Medicated THC Nerds", and U.S. currency. The handgun had been reported stolen to the Tallahassee Police Department. The LCSO Narcotics Unit was called in to assist with the investigation.

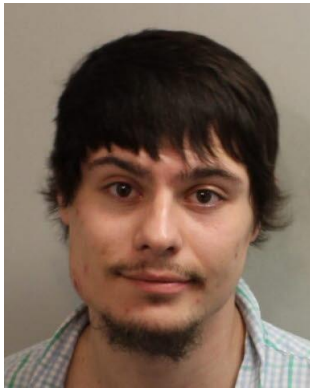
Bragg was taken to the Leon County Detention Facility.

"This is a perfect example of our community working together to make Leon County a safer place to live, work and play. One gun, one arrest, one grand. If you see someone illegally possessing a firearm, send the tip in through Cease Fire and Big Bend Crime Stoppers and help your Leon County Sheriff's Office get guns out of the hands of those who wish to do our community harm," said Sheriff Walt McNeil. Tipsters who contact Big Bend Crime Stoppers at (850) 574-TIPS will remain anonymous and are eligible for a \$1,000 reward.
