LCSO Narcotics Search Warrant Nets 10 Guns, 10 Arrests

Yesterday, around 8:30 am, the Leon County Sheriff's Office Narcotics Unit served a search warrant in the 1200 block of Poplar Drive. This was the culmination of several months of investigation after complaints from area residents.

LCSO utilized several agency units to assist with serving the search warrant, this including: Special Projects Investigations Detection Enforcement Response (SPIDER), K-9, Aviation, Warrants, Property Crimes, and Internet Crimes Against Children (ICAC) Units.

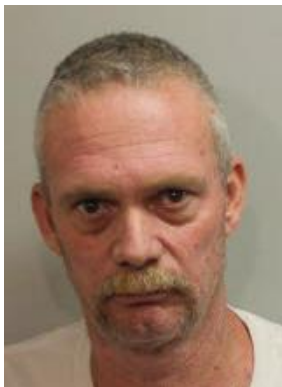
The LCSO SWAT team and Tallahassee Police Department TAC team also assisted with the service of the warrant.

During the search of the residence and outlying buildings, deputies located 10 firearms, 171 grams of methamphetamine oil, eight grams of methamphetamine, and ammunition for the firearms.

Ten people were located inside the residence and all were arrested for drug related charges, firearms related charges, and/or outstanding warrants.

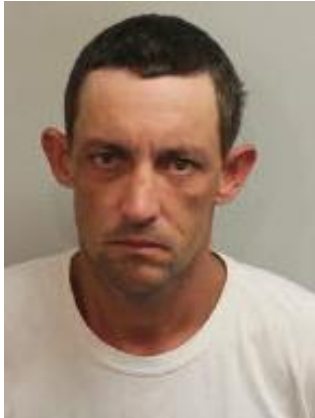
