LCSO Narcotics Unit Makes Big Bust

As a result of citizens' complaints and a confidential source, the Leon County Sheriff's Office Narcotics Unit launched a general investigation approximately six weeks ago. Yesterday, investigators obtained a search warrant for a residence within the Commons apartment complex, located at 1325 W. Tharpe Street. During the investigation, deputies learned that the occupants were heavily armed with various firearms. As a result, the SWAT team was requested to make entry and secure the residence. Upon entry, the SWAT team encountered 6 black male subjects. One subject was released on scene. Probable cause was developed for the arrest of the remaining 5 subjects. During a search of the residence, detectives discovered and seized more than 4 pounds of cannabis, prescription pills, MDMA (ecstasy), over \$10,000 and 10 firearms.

The investigation is ongoing, including one outstanding warrant.

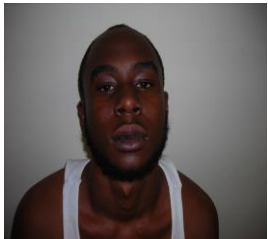

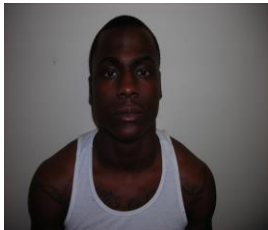

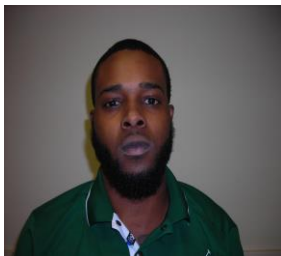
