LCSO Narcotics Unit Seizes Guns and Drugs

On August 29, 2017, members of the Leon County Sheriff's Office Narcotics Unit executed a search warrant at a residence on Lucky Acres Trail in southwest Leon County. The search warrant was a result of an on-going investigation regarding the illegal sale of prescription pills.

During the search of the residence detectives located and seized numerous items including the prescription drugs; Oxycodone, Hydromorphone, and Suboxone. They also seized MDMA tablets and marijuana. In addition to the narcotics, detectives recovered numerous firearms, including three rifles and five handguns. Several of the firearms were reported as stolen.

Three individuals were arrested related to the investigation. Those arrested include; Erma Lurry 65, Deante Hinson 31, and John Robinson 62. All three arrestees were at the scene during the execution of the search warrant and all reside at the residence. They were arrested and transported to the Leon County Detention Center without incident.
