### LCSO VICE Shuts Down Another Drug House

On Friday, April 23, 2010, Leon County VICE Detectives served a search warrant at 9823 Fair Oaks Lane. This residence was identified as a major distribution point of much of the crack cocaine in the Woodville Community. Many Woodville residents have reported an increase in illegal drug activity and this operation was in response to those concerns. When Detectives arrived at the residence, Paul Blake DOB: 04/25/1978 was in the front yard and attempted to flee. As Paul Blake ran away, he threw down crack cocaine which was in his possession. Detectives captured Paul Blake and recovered the crack cocaine which he had thrown on the ground. Paul Blake was charged with Possession of Crack Cocaine with Intent to Sell, Possession of less than 20 grams marijuana, Resisting Arrest without Violence and Tampering with Evidence.

During the search of the residence, Detectives located crack cocaine, a rifle, cash and drug paraphernalia. The homeowner, Robert Chambers DOB: 06/08/1968, and another resident, Mercedes Robinson DOB: 08/01/1991, were arrested and charged with Possession of Crack Cocaine with Intent to Sell and Maintaining a drug house. Anthony Blake DOB: 12/18/1984 was also arrested for Maintaining a drug house and Possession of Drug Paraphernalia.

Shutting down these drug houses, which are a source of much of the crack cocaine in our community, is a public safety priority" said Sheriff Larry Campbell. "These recent operations in western and southern Leon County will continue county-wide, as this Office responds to the information and support provided by the public."

As part of this on-going and active investigation Detectives have also identified Robert Lee Blake as a suspect involved in the illegal drug sales at this residence. Robert Blake is wanted for three (3) counts of Possession of Crack Cocaine and Maintaining a Drug House.
