Update: Three Arrested for the Murder of Robert Parkes

On May 19, 2009 Leon County Sheriff's Deputies were called to 4921 Outlook Court in reference to checking on the welfare of 35 year old Robert Parkes. Parkes had not shown up for work and his co-workers had become concerned. Upon arrival at the residence Sheriff's Deputies found Parkes deceased inside the residence. Violent Crimes Detectives responded to the scene and found indications of foul play. An autopsy was performed on May 20, 2009, which confirmed Parkes death was the result of homicide.

During the course of the investigation, Detectives obtained information that Tyrese Faust, Alexandria Ford and Latorya Pate may have been responsible for Parkes murder. On Friday May 22, 2009, Faust, Ford and Pate were located and through interviews and evidence collected during the investigation, probable cause for all three subjects was established and they were arrested.

The preliminary investigation has revealed that Faust, Ford and Pate went to Parkes residence for the purpose of robbing him. During the robbery Parkes was shot and died as a result. This investigation continues and other arrests could be made.

Sheriff Larry Campbell said "While I am pleased that these murderers have been captured and arrested, my thoughts and prayers are with the family of Parkes during this time of loss. Since the discovery of Parkes homicide this office has collected significant evidence, tirelessly followed every lead and conducted countless interviews. The determination and professionalism of the Detectives assigned to this investigation has resulted in the arrest of Faust, Ford and Pate within three days of this murder being discovered. We will continue the investigation into the homicide of Robert Parkes to ensure that all responsible are held accountable."
