## Tips lead to Identity of Wal-Mart Grand Theft Suspects

On Tuesday July 8, 2008, Leon County Sheriff's Detectives sought assistance from the public in identifying grand theft suspects. It was reported on Saturday, June 21, 2008, at approximately 12:45a.m. that a male entered the camera department at the Wal-Mart located at 3535 Apalachee Parkway. The subject was seen entering the camera display cabinets in the electronics department of the store. At 12:49a.m. two females pushing shopping carts entered the camera section of the store. A second male was seen in the area and appeared to be a look-out person. The two females and the first male were seen removing cameras from the display cabinets and placing the cameras inside the shopping carts. After emptying the display cabinets, both females pushed the shopping carts to the infant section of the store and emptied two infant car seat boxes. The subjects then began placing the stolen cameras inside the infant car seat boxes. After leaving the area for a short time the subjects returned, retrieved the car seat boxes filled with the stolen cameras and walked out of the store without paying for the items. The total theft is valued at approximately \$13,000.

Attached to the release were security camera images of the suspects stealing the cameras. After this information was reported by the media, Detective John Rudd began receiving tips as to the identify of the suspects from Crime Stoppers, the Leon County Sheriff's Office Unsolved Crimes Web Site and other law enforcement officers. These tips enabled Detective Rudd to identify Casey Bennett and Rudolph Corbett as two of the suspects pictured in security camera images. Bennett is pictured with short blonde hair, but she may changed her hair color, style and/or length since this crime. Detectives are still seeking information as to the identity of the two other subjects pictured leaving the store with Corbett. Both Bennett and Corbett have active arrest warrants for grand theft.
