### Six Arrested In Drug Investigation

On July 22, 2011, the Leon County Sheriff's Office arrested six people in connection with a month long undercover drug investigation. Early this morning, members of the Leon County Sheriff's Office Vice unit served a search warrant at 9459 Leroy Circle, in eastern Leon County.

During the search, detectives located and seized crack cocaine, marijuana, illegal prescription medication, 5 firearms (including 2 assault rifles and two Tech-9 assault handguns), drug paraphernalia, stolen computer equipment, stolen lawn equipment and stolen musical instruments.

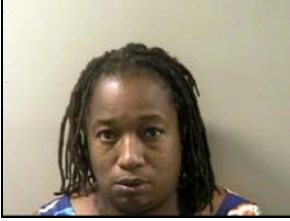
