### Three Armed Robbery Suspects Arrested

Last night, at approximately 9:30PM, Leon County Sheriff's Deputies responded to the Market Square Liquor store located at 1783 Oak Ridge Road in reference to an armed robbery. The victims reported that two male suspects, armed with handguns, entered the store and demanded money. The clerk complied and the suspects left the store with stolen cash and bottles of Crown Royal liquor. The suspect description and actions of the suspects were the same as an earlier robbery, at this same location, which occurred on Tuesday October 27, 2009.

As Deputies investigated this robbery a citizen reported witnessing two black males wearing bandanas running from the store and a primer gray or blue late 1980's model vehicle, with a broken tail light, traveling south on Old Woodville Highway at a high rate of speed. A bulletin of this robbery and the suspect vehicle information was issued to local law enforcement. Later in the evening, Florida Highway Patrol Trooper Ryan Martina observed the suspect vehicle at a Gas Station at 5382 Crawfordville Highway and took three suspects into custody. The suspects were identified as Rashard Rouise, Isaac Jackson Jr. and Steven Garrett. As Deputies took the suspects into custody, 10grams of powder cocaine packaged in several small baggies were found in Jackson's back pocket. Deputies also discovered a handgun in the vehicle along with Crown Royal bags, 4 grams of marijuana, .4 grams of crack cocaine and a digital scale. Also Jackson and Garrett were in possession of money believed to be stolen during the robbery.

All three subjects were transported to the Leon County Sheriffs Office and interviewed by a Violent Crimes Detective. During the interviews information was provided by the suspects, which confirmed they committed the Market Square Liquor store robbery. All three subjects were booked into the Leon County Jail.
