### Operation "Street Sweep"

On Monday August 24, 2009, Sheriff Larry Campbell attended a town hall meeting at Bethel Missionary Baptist Church. Citizens in attendance voiced their concerns of crime in the French Town Community and in other areas of Tallahassee/Leon County. Citizens also voiced their support for increased law enforcement efforts to reduce street crimes. After hearing the concerns of many local residents and receiving community support, Sheriff Campbell directed Operation "Street Sweep" to be implemented. "Street Sweep" consisted of heightened patrols in the French Town community by uniformed Deputy Sheriffs, prostitution stings, street level buy/bust operations and gang activity suppression efforts. The Tallahassee Police Department, Florida Department of Corrections and the Florida Department of Juvenile Justice assisted with this initiative.

Operation "Street Sweep" was not exclusively a Frenchtown Community initiative. "Street Sweep" also targeted other citizen complaint areas within Tallahassee/Leon County. These areas included south Tallahassee, Bond Community, Killearn Community, north, south and western Leon County. "Street Sweep" is the first initiative of an on-going effort to target and reduce street level criminal activity in Tallahassee/Leon County by the Leon County Sheriff's Office.

Sheriff Larry Campbell said "To the many citizens who voiced their concerns during the recent town hall meeting; I am committed to making the streets as safe as possible for all Tallahassee/Leon County citizens. With the support, encouragement and information of concerned citizens throughout Tallahassee/Leon County this agency will continue to target the street level drug dealers, prostitutes, gang members and wanted persons who are a danger to this community.

Operation "Street Sweep" resulted in thirty-nine (39) arrests, with sixty-nine (69) individual charges, ranging from Felony Prostitution, Conspiracy to Sell Cocaine to Violation of Probation arrests. An investigation by the Leon County Sheriff's Office Gang Unit revealed that three (3) of the persons arrested were confirmed gang members. Sheriff Campbell asks any citizen who may have information about actual or suspected criminal activity to call the Leon County Sheriff's Office at (850) 922-3300 or Crime Stoppers at (850) 574-TIPS.

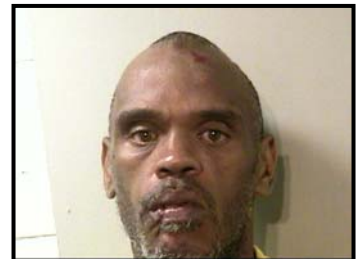
