### **LCSO Deputies Make Multiple Arrests in Directed Patrol Efforts**

Over the last week, Leon County Sheriff's Office deputies performed directed patrol operations within Leon County. These operations focused on high-crime areas to help prevent criminal activity and maintain high visibility within specific communities during enforcement efforts.

As a result of these enforcement periods, deputies made several arrests involving stolen handguns, drugs, and illegal possession of weapons by convicted felons.

This operation yielded the following:

- five loaded handgun seizures (three of which were reported stolen to the Tallahassee Police Department, the Leon County Sheriff's Office, and law enforcement authorities in Georgia)
- more than 213 grams of marijuana
- 12 grams of synthetic cathinone (bathsalts)
- 3 digital weighing scales
- over \$4000 in cash

When LCSO launched the ALLinLEON initiative in 2019, a comprehensive plan to fight crime in the county, one of the critical components for the ongoing program's success was to get guns out of the hands of violent offenders. These arrests illustrate the commitment of LCSO to combat crime in our communities and continue to make Leon County a safer place to live, work, and play.

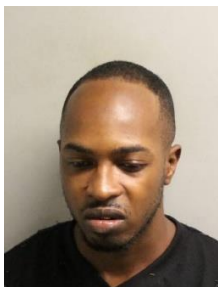
