## **LCSO Narcotics Unit Makes Multiple Arrests at Drug Houses**

On July 25<sup>th</sup>, 2018, Leon County Sheriff's Office Narcotics Detectives served two search warrants. One search warrant was in the 1100 block of Ellington Court and the other in the 2000 block of Keith Street.

While searching both houses, detectives found about 16 grams of crack cocaine packaged for sale, several grams of powder cocaine, about 10 grams of methylenedioxy-methamphetamine (Ecstasy) packaged for sale, over \$4000 dollars in cash, and numerous items of drug paraphernalia (including items used to manufacture crack cocaine).

32 year old Darilyn Smith, 23 year old Damion Boone, 54 year old Michael Campbell, and 53 year old Leslie Gordon Jackson were arrested during the service of the search warrants.

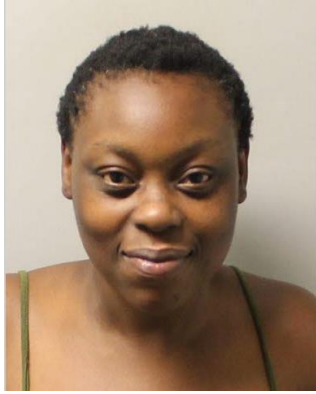

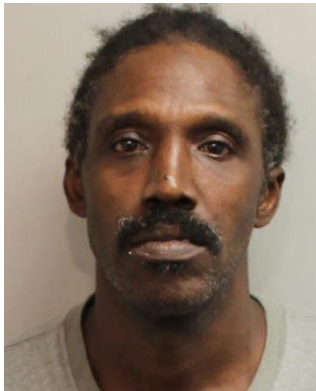
