LCSO Narcotics Unit Serves Four Search Warrants and Makes Multiple Arrests in Countywide Round Up

The Leon County Sheriff's Office Narcotics Unit has been very busy this week. As several independent investigations came to a conclusion this week the Narcotics Unit obtained search warrants for four different residences around the county. During the search warrants that were executed on Cathedral Drive, 3500 Block of Roberts Avenue, Oak View Drive and Pepper Drive; detectives seized approximately 2 ounces of cocaine (approximate value \$5600), 14 ounces cannabis (approximate value of \$4000) 3 grams of Alpha PVP (approximate value of \$300) and over 200 varied prescription pills (approximate value of \$3000).

In addition to the drugs seized, a total of six defendants were taken into custody on drug related charges. All defendants were taken to the Leon County Detention Facility without incident.

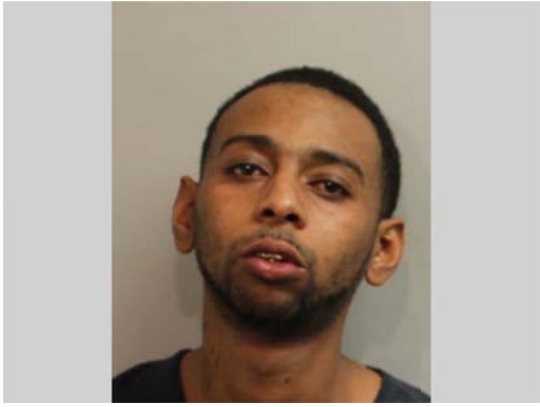
