## LCSO, TPD Charge Suspect for Two Armed Robberies

On September 10, 2020, LCSO deputies responded to an armed robbery at a business in the 3800 block of North Monroe Street. Deputies learned two subjects, with their faces covered, entered the business and robbed the clerk at gunpoint. One suspect used a chrome, semi-automatic handgun, while the other suspect used a black rifle. The subjects took six dollars from the clerk's register and other items belonging to the clerk. The suspects left the scene in a black Acura passenger car.

LCSO detectives learned 20-year-old Keiron Sarjeant was stopped by another agency while driving a black Acura on September 23. Sarjeant was subsequently arrested for carrying a concealed firearm found inside that vehicle. Through investigative means, LCSO detectives determined the black Acura also contained clothing that matched the robbery suspect's clothing and property owned by the clerk that was taken during the September 10 robbery. The black Acura also had visible exterior markings that matched the suspect's vehicle in the security video.

On September 28, Sarjeant was arrested and transported to the Leon County Detention Facility.

Tallahassee Police investigators already developed Sarjeant as a possible suspect in an armed robbery from September 18. He was suspected of entering a business located in the 1500 block of West Tennessee Street shortly after 8 p.m. and robbing it at gunpoint. Evidence obtained after his arrest enabled TPD to file an additional Robbery with a Firearm charge on September 29.
