LCSO, U.S. MARSHALS AND ATF ARREST 11 DURING NARCOTICS SEARCH WARRANT

TALLAHASSEE, FLORIDA – On November 19 and 20, Members of the Leon County Sheriff's Office Vice/Narcotics Unit, K-9 Unit, and Aviation Unit, joined by the U.S. Marshals Service and U.S. Bureau of Alcohol, Tobacco, Firearms and Explosives, last week arrested 11 individuals while serving a narcotics-related search warrant in the 100 block of Americana Street in the Pine Ridge Mobile Home Park.

The search warrant was the culmination of multiple controlled buys from the residence. During a search of the residence, county detectives and federal agents found approximately 100 grams of crack cocaine and cocaine, approximately 105 grams of cannabis, approximately 565 grams of spice (synthetic narcotic), a loaded, stolen Smith & Wesson 9MM handgun and magazine, \$3,695 in U.S. currency, and numerous items of drug paraphernalia including digital scales and baggies.

Seven arrests were made stemming from the investigation and results of the search warrant, and another four arrests were made for outstanding warrants of individuals who were in the house at the time the warrant was served.

"These types of collaborative efforts are what is needed to make Leon County a safer place to live, work, and play. We will leave no stone unturned in our efforts to drive the criminal element out of our community," said Sheriff Walt McNeil.

"The people of Leon County are safer as a result of these arrests and the strong partnership between federal law enforcement and the Sheriff's Office," said Lawrence Keefe, United States Attorney for the Northern District of Florida. "Working together, we will continue to pursue, apprehend, and prosecute criminals to make the streets safer for the law-abiding people of this community."

- Tony Kilpatrick, 22, Charges: Trafficking in Cocaine; Sale of Cocaine (2 counts); Grand Theft Firearm; Possession of Firearm by Convicted Felon; Maintaining a Drug Trafficking Structure; and Possession of Drug Paraphernalia
