SILVER ALERT Issued for Missing 77-year-old Woman

On April 19, 2020, the Leon County Sheriff's Office received a report of a missing person, 77-year-old Lue Anna Bowens. Family members advised Bowens was last seen in the 6000 block of Ellenmann Lane in Leon County around 11:00 AM.

Bowens, who is known by "Anna", was last seen wearing a light blue t-shirt with "Wells Family Reunion" written on it, dark blue jeans, black shoes, a blue surgical mask, and blue surgical gloves. She may be traveling in a 2005 tan four-door Honda Accord bearing a Florida breast cancer license tag reading "K H I O G." Bowens was last known to be traveling in the area of Marianna, Florida in Jackson County.
